- 7. Legislative Report Terry Brown discussed NLRB new ruling going into effect April, 2015. New rule speeds up how quickly a new election is held. It eliminates a previously required 25-day period. Also includes a new rule on employee use of employer email systems for union organizing. Employees now also have a protected right under NLRB case law to use the employer's email system to send emails to co-workers encouraging union support. See more details in our February Newsletter.
- 8. Group discussion regarding new Work Comp Case in Pottawatomie County. A judge recently concluded that an employee's injury was foreseeable and therefore his injury did not fit within the definition of a compensable injury. This allows the case to proceed in state court before a jury.

- 10. Proposed plan to take new group picture at next meeting for website.
